

Vidyo and Kaltura have jointly developed the Vidyo-Kaltura API Connector, a lightweight software component available at no charge from Kaltura. Once configured by the system administrator, VidyoReplay automatically uploads conference recordings to the Kaltura cloud, processed and managed according to the enterprise's needs, and then made available to viewers worldwide through a YouTube-like portal.

World Class Media Streaming, Management, and Storage

Leveraging Kaltura's robust media management capabilities and flexible APIs, the enterprise can also integrate the conference recordings with existing Content Management Systems (CMS) or Learning Management Systems (LMS), such as SharePoint, Drupal, Blackboard, Moodle, and others.

Based on moderation and access control rules set by administrators, end users can now retain full control of their recordings, share links to recordings, and search through the archive. In addition, content managed by Kaltura can be streamed to broad global audiences connecting through fixed endpoints and mobile devices, including iOS, Android, Blackberry, set-top boxes, and tablets, under a variety of network conditions.
